

Weekly Analysis

November 28, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 27,750 last week, a decrease of 8.0 percent from the prior week's figure of 30,177 and a 230.9 percent increase from the November 2019 weekly average of 8,387. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 47. Pandemic Unemployment Compensation (PUA) initial claims totaled 36,865.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 142,816 last week, a decrease of 4.0 percent from the prior week's figure of 148,802 and a 234.4 percent increase from the November 2019 weekly average of 42,714. Continued claims under Title 5 totaled 483. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 97,556 while PUA continued claims totaled 381,988. Extended Benefits (EB) continued claims totaled 16,404.
