

Weekly Analysis

February 12, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 15,109 last week, an increase of 55.5 percent from the prior week's figure of 9,719 and a 88.2 percent decrease from the February 2021 weekly average of 128,525. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled 9.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 59,258 last week, an increase of 3.3 percent from the prior week's figure of 57,351 and a 67.3 percent decrease from the February 2021 weekly average of 181,324. Continued claims under Title 5 totaled 210. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 384 while PUA continued claims totaled 9,086. Extended Benefits (EB) continued claims totaled 31.
