

Weekly Analysis

June 11, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 11,295 last week, an increase of 19.1 percent from the prior week's figure of 9,484 and a 14.5 percent decrease from the June 2021 weekly average of 13,204. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 23. Pandemic Unemployment Compensation (PUA) initial claims totaled 9.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 31,594 last week, an increase of 9.0 percent from the prior week's figure of 28,985 and a 59.9 percent decrease from the June 2021 weekly average of 78,832. Continued claims under Title 5 totaled 122. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 85 while PUA continued claims totaled 1,133. Extended Benefits (EB) continued claims totaled 4.
