

Weekly Analysis

July 2, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 12,481 last week, a decrease of 7.4 percent from the prior week's figure of 13,482 and a 15.6 percent increase from the July 2021 weekly average of 10,801. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 24. Pandemic Unemployment Compensation (PUA) initial claims totaled 5.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 34,972 last week, an increase of 7.2 percent from the prior week's figure of 32,612 and a 44.6 percent decrease from the July 2021 weekly average of 63,092. Continued claims under Title 5 totaled 153. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 38 while PUA continued claims totaled 736. Extended Benefits (EB) continued claims totaled zero.
