

Weekly Analysis

July 9, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 14,724 last week, an increase of 18.0 percent from the prior week's figure of 12,481 and a 36.3 percent increase from the July 2021 weekly average of 10,801. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 35,028 last week, an increase of 0.2 percent from the prior week's figure of 34,972 and a 44.5 percent decrease from the July 2021 weekly average of 63,092. Continued claims under Title 5 totaled 161. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 48 while PUA continued claims totaled 842. Extended Benefits (EB) continued claims totaled 1.
