

# Weekly Analysis

July 23, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 9,254 last week, a decrease of 16.7 percent from the prior week's figure of 11,113 and a 14.3 percent decrease from the July 2021 weekly average of 10,801. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 12. Pandemic Unemployment Compensation (PUA) initial claims totaled 3.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 35,612 last week, a decrease of 7.2 percent from the prior week's figure of 38,356 and a 43.6 percent decrease from the July 2021 weekly average of 63,092. Continued claims under Title 5 totaled 138. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 101 while PUA continued claims totaled 704. Extended Benefits (EB) continued claims totaled zero.
