

# Weekly Analysis

July 30, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,615 last week, a decrease of 17.7 percent from the prior week's figure of 9,254 and a 29.5 percent decrease from the July 2021 weekly average of 10,801. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 33,319 last week, a decrease of 6.4 percent from the prior week's figure of 35,612 and a 47.2 percent decrease from the July 2021 weekly average of 63,092. Continued claims under Title 5 totaled 146. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 54 while PUA continued claims totaled 647. Extended Benefits (EB) continued claims totaled zero.
