

Weekly Analysis

August 6, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,891 last week, an increase of 3.6 percent from the prior week's figure of 7,615 and a 30.4 percent decrease from the August 2021 weekly average of 11,341. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 10. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 33,528 last week, an increase of 0.6 percent from the prior week's figure of 33,319 and a 46.7 percent decrease from the August 2021 weekly average of 62,936. Continued claims under Title 5 totaled 141. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 69 while PUA continued claims totaled 352. Extended Benefits (EB) continued claims totaled zero.
