

Weekly Analysis

August 13, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 6,227 last week, a decrease of 21.1 percent from the prior week's figure of 7,891 and a 45.1 percent decrease from the August 2021 weekly average of 11,341. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 32,786 last week, a decrease of 2.2 percent from the prior week's figure of 33,528 and a 47.9 percent decrease from the August 2021 weekly average of 62,936. Continued claims under Title 5 totaled 138. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 109 while PUA continued claims totaled 619. Extended Benefits (EB) continued claims totaled 5.
