

Weekly Analysis

August 27, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 6,021 last week, a decrease of 4.6 percent from the prior week's figure of 6,310 and a 46.9 percent decrease from the August 2021 weekly average of 11,341. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 21. Pandemic Unemployment Compensation (PUA) initial claims totaled 4.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 29,876 last week, a decrease of 4.7 percent from the prior week's figure of 31,358 and a 52.5 percent decrease from the August 2021 weekly average of 62,936. Continued claims under Title 5 totaled 152. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 60 while PUA continued claims totaled 387. Extended Benefits (EB) continued claims totaled zero.
