

Weekly Analysis

September 3, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 6,680 last week, an increase of 10.9 percent from the prior week's figure of 6,021 and a 34.4 percent decrease from the September 2021 weekly average of 10,184. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 28,001 last week, a decrease of 6.3 percent from the prior week's figure of 29,876 and a 56.7 percent decrease from the September 2021 weekly average of 64,640. Continued claims under Title 5 totaled 149. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 51 while PUA continued claims totaled 321. Extended Benefits (EB) continued claims totaled 5.
