

Weekly Analysis

September 10, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 5,954 last week, a decrease of 10.9 percent from the prior week's figure of 6,680 and a 41.5 percent decrease from the September 2021 weekly average of 10,184. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled 2.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 27,735 last week, a decrease of 0.9 percent from the prior week's figure of 28,001 and a 57.1 percent decrease from the September 2021 weekly average of 64,640. Continued claims under Title 5 totaled 149. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 45 while PUA continued claims totaled 275. Extended Benefits (EB) continued claims totaled zero.
