

# Weekly Analysis

October 1, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,240 last week, a decrease of 9.5 percent from the prior week's figure of 8,004 and a 15.5 percent decrease from the October 2021 weekly average of 8,569. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 24. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 28,294 last week, an increase of 3.1 percent from the prior week's figure of 27,436 and a 37.8 percent decrease from the October 2021 weekly average of 45,491. Continued claims under Title 5 totaled 138. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 60 while PUA continued claims totaled 333. Extended Benefits (EB) continued claims totaled 12.
