

Weekly Analysis

October 22, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 6,396 last week, an increase of 7.4 percent from the prior week's figure of 5,954 and a 25.4 percent decrease from the October 2021 weekly average of 8,569. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 19. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 28,353 last week, an increase of 1.7 percent from the prior week's figure of 27,889 and a 37.7 percent decrease from the October 2021 weekly average of 45,491. Continued claims under Title 5 totaled 146. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 68 while PUA continued claims totaled 403. Extended Benefits (EB) continued claims totaled zero.
