

Weekly Analysis

November 5, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,475 last week, an increase of 16.2 percent from the prior week's figure of 6,431 and a 10.9 percent decrease from the November 2021 weekly average of 8,385. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 17. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 28,042 last week, an increase of 1.0 percent from the prior week's figure of 27,778 and a 26.3 percent decrease from the November 2021 weekly average of 38,025. Continued claims under Title 5 totaled 152. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 82 while PUA continued claims totaled 237. Extended Benefits (EB) continued claims totaled zero.
