

Weekly Analysis

November 19, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 10,076 last week, an increase of 31.5 percent from the prior week's figure of 7,664 and a 20.2 percent increase from the November 2021 weekly average of 8,385. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 27. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 32,064 last week, an increase of 10.1 percent from the prior week's figure of 29,112 and a 15.7 percent decrease from the November 2021 weekly average of 38,025. Continued claims under Title 5 totaled 186. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 76 while PUA continued claims totaled 710. Extended Benefits (EB) continued claims totaled zero.
