

Weekly Analysis

November 26, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 10,654 last week, an increase of 5.7 percent from the prior week's figure of 10,076 and a 27.1 percent increase from the November 2021 weekly average of 8,385. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 33,539 last week, an increase of 4.6 percent from the prior week's figure of 32,064 and a 11.8 percent decrease from the November 2021 weekly average of 38,025. Continued claims under Title 5 totaled 159. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 49 while PUA continued claims totaled 452. Extended Benefits (EB) continued claims totaled zero.
