

Weekly Analysis

December 3, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 13,083 last week, an increase of 22.8 percent from the prior week's figure of 10,654 and a 30.8 percent increase from the December 2021 weekly average of 10,001. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 26. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 39,269 last week, an increase of 17.1 percent from the prior week's figure of 33,539 and a 1.5 percent increase from the December 2021 weekly average of 38,685. Continued claims under Title 5 totaled 185. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 57 while PUA continued claims totaled 502. Extended Benefits (EB) continued claims totaled zero.
