

Weekly Analysis

January 7, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 14,050 last week, an increase of 1.9 percent from the prior week's figure of 13,787 and a 18.0 percent increase from the January 2022 weekly average of 11,911. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 23. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 60,632 last week, an increase of 13.4 percent from the prior week's figure of 53,452 and a 12.8 percent increase from the January 2022 weekly average of 53,761. Continued claims under Title 5 totaled 184. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 90 while PUA continued claims totaled 145. Extended Benefits (EB) continued claims totaled zero.
