

Weekly Analysis

July 1, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 21,306 last week, an increase of 16.6 percent from the prior week's figure of 18,270 and a 91.8 percent increase from the July 2022 weekly average of 11,108. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 9. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 46,172 last week, an increase of 1.6 percent from the prior week's figure of 45,457 and a 20.8 percent increase from the July 2022 weekly average of 38,221. Continued claims under Title 5 totaled 128. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 34 while PUA continued claims totaled 84. Extended Benefits (EB) continued claims totaled zero.
