

Weekly Analysis

August 12, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 23,887 last week, a decrease of 0.0 percent from the prior week's figure of 23,894 and a 269.7 percent increase from the August 2022 weekly average of 6,461. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,514 last week, an increase of 0.6 percent from the prior week's figure of 42,256 and a 43.6 percent increase from the August 2022 weekly average of 29,598. Continued claims under Title 5 totaled 124. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 26 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
