

Weekly Analysis

September 2, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 10,535 last week, a decrease of 21.2 percent from the prior week's figure of 13,369 and a 55.5 percent increase from the September 2022 weekly average of 6,775. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 12. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 36,357 last week, a decrease of 4.3 percent from the prior week's figure of 37,974 and a 40.6 percent increase from the September 2022 weekly average of 25,855. Continued claims under Title 5 totaled 92. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 44 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
