

# Weekly Analysis

**November 18, 2023**

Ohio Law initial claims, representing newly unemployed persons, totaled 7,488 last week, an increase of 8.1 percent from the prior week's figure of 6,928 and a 21.0 percent decrease from the November 2022 weekly average of 9,483. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 38,914 last week, an increase of 2.6 percent from the prior week's figure of 37,911 and a 23.9 percent increase from the November 2022 weekly average of 31,398. Continued claims under Title 5 totaled 108. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 49 while PUA continued claims totaled 51. Extended Benefits (EB) continued claims totaled zero.
