

Weekly Analysis

November 25, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 8,678 last week, an increase of 15.9 percent from the prior week's figure of 7,488 and a 8.5 percent decrease from the November 2022 weekly average of 9,483. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 11. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 38,493 last week, a decrease of 1.1 percent from the prior week's figure of 38,914 and a 22.6 percent increase from the November 2022 weekly average of 31,398. Continued claims under Title 5 totaled 124. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 21 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
