

Weekly Analysis

June 15, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 5,944 last week, a decrease of 6.9 percent from the prior week's figure of 6,382 and a 66.1 percent decrease from the June 2023 weekly average of 17,527. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 12. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 40,620 last week, an increase of 3.5 percent from the prior week's figure of 39,256 and a 2.2 percent decrease from the June 2023 weekly average of 41,550. Continued claims under Title 5 totaled 133. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 12 while PUA continued claims totaled 49. Extended Benefits (EB) continued claims totaled zero.
