

Weekly Analysis

June 29, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 5,879 last week, an increase of 14.1 percent from the prior week's figure of 5,154 and a 66.5 percent decrease from the June 2023 weekly average of 17,527. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 43,330 last week, an increase of 6.1 percent from the prior week's figure of 40,835 and a 4.3 percent increase from the June 2023 weekly average of 41,550. Continued claims under Title 5 totaled 117. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 15 while PUA continued claims totaled 1. Extended Benefits (EB) continued claims totaled zero.
