

# Weekly Analysis

July 6, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 7,298 last week, an increase of 24.1 percent from the prior week's figure of 5,879 and a 67.5 percent decrease from the July 2023 weekly average of 22,470. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 9. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 40,902 last week, a decrease of 5.6 percent from the prior week's figure of 43,330 and a 16.2 percent decrease from the July 2023 weekly average of 48,784. Continued claims under Title 5 totaled 129. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 22 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
