

Weekly Analysis

July 13, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 9,077 last week, an increase of 24.4 percent from the prior week's figure of 7,298 and a 59.6 percent decrease from the July 2023 weekly average of 22,470. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 13. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 44,711 last week, an increase of 9.3 percent from the prior week's figure of 40,902 and a 8.3 percent decrease from the July 2023 weekly average of 48,784. Continued claims under Title 5 totaled 115. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 5 while PUA continued claims totaled 1. Extended Benefits (EB) continued claims totaled zero.
