

Weekly Analysis

July 20, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 7,662 last week, a decrease of 15.6 percent from the prior week's figure of 9,077 and a 65.9 percent decrease from the July 2023 weekly average of 22,470. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 10. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 46,446 last week, an increase of 3.9 percent from the prior week's figure of 44,711 and a 4.8 percent decrease from the July 2023 weekly average of 48,784. Continued claims under Title 5 totaled 114. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 11 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
