

# Weekly Analysis

October 12, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 7,290 last week, a decrease of 25.4 percent from the prior week's figure of 9,767 and a 17.5 percent increase from the October 2023 weekly average of 6,203. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 17. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,841 last week, an increase of 11.0 percent from the prior week's figure of 38,579 and a 5.2 percent increase from the October 2023 weekly average of 40,709. Continued claims under Title 5 totaled 114. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 12 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
