

# Weekly Analysis

October 26, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 6,062 last week, an increase of 11.5 percent from the prior week's figure of 5,439 and a 2.3 percent decrease from the October 2023 weekly average of 6,203. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,037 last week, a decrease of 4.3 percent from the prior week's figure of 43,911 and a 3.3 percent increase from the October 2023 weekly average of 40,709. Continued claims under Title 5 totaled 116. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 3 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
