

# Weekly Analysis

November 16, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 6,614 last week, a decrease of 14.8 percent from the prior week's figure of 7,765 and a 13.7 percent decrease from the November 2023 weekly average of 7,666. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 46,555 last week, an increase of 1.3 percent from the prior week's figure of 45,977 and a 25.3 percent increase from the November 2023 weekly average of 37,140. Continued claims under Title 5 totaled 125. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 2 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
