

Weekly Analysis

November 23, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 8,125 last week, an increase of 22.8 percent from the prior week's figure of 6,614 and a 6.0 percent increase from the November 2023 weekly average of 7,666. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 18. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 44,447 last week, a decrease of 4.5 percent from the prior week's figure of 46,555 and a 19.7 percent increase from the November 2023 weekly average of 37,140. Continued claims under Title 5 totaled 133. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 13 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
