

Weekly Analysis

December 21, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 9,315 last week, an increase of 8.5 percent from the prior week's figure of 8,589 and a 11.0 percent decrease from the December 2023 weekly average of 10,465. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 57,029 last week, an increase of 4.7 percent from the prior week's figure of 54,474 and a 21.4 percent increase from the December 2023 weekly average of 46,993. Continued claims under Title 5 totaled 169. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 4 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
