

# Weekly Analysis

January 25, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 7,263 last week, a decrease of 15.6 percent from the prior week's figure of 8,607 and a 22.4 percent decrease from the January 2024 weekly average of 9,355. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 71,112 last week, a decrease of 4.8 percent from the prior week's figure of 74,694 and a 22.3 percent increase from the January 2024 weekly average of 58,167. Continued claims under Title 5 totaled 170. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 16 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
