

# Weekly Analysis

February 15, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 6,028 last week, a decrease of 6.5 percent from the prior week's figure of 6,449 and a 3.3 percent increase from the February 2024 weekly average of 5,833. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 69,570 last week, a decrease of 1.0 percent from the prior week's figure of 70,292 and a 25.2 percent increase from the February 2024 weekly average of 55,569. Continued claims under Title 5 totaled 175. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 5 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
