

# Weekly Analysis

March 1, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 6,537 last week, a decrease of 1.6 percent from the prior week's figure of 6,641 and a 28.3 percent increase from the March 2024 weekly average of 5,095. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 27. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 68,383 last week, an increase of 0.2 percent from the prior week's figure of 68,223 and a 21.8 percent increase from the March 2024 weekly average of 56,161. Continued claims under Title 5 totaled 181. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 5 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
