

Weekly Analysis

March 22, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 5,724 last week, an increase of 4.8 percent from the prior week's figure of 5,462 and a 12.3 percent increase from the March 2024 weekly average of 5,095. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 13. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 61,943 last week, a decrease of 3.7 percent from the prior week's figure of 64,334 and a 10.3 percent increase from the March 2024 weekly average of 56,161. Continued claims under Title 5 totaled 189. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 6 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
