

Weekly Analysis

July 12, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 6,958 last week, a decrease of 1.5 percent from the prior week's figure of 7,063 and a 0.1 percent increase from the July 2024 weekly average of 6,953. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 51,528 last week, an increase of 5.4 percent from the prior week's figure of 48,910 and a 19.5 percent increase from the July 2024 weekly average of 43,114. Continued claims under Title 5 totaled 178. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 1 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
