

Weekly Analysis

July 19, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 5,143 last week, a decrease of 26.1 percent from the prior week's figure of 6,958 and a 26.0 percent decrease from the July 2024 weekly average of 6,953. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 51,791 last week, an increase of 0.5 percent from the prior week's figure of 51,528 and a 20.1 percent increase from the July 2024 weekly average of 43,114. Continued claims under Title 5 totaled 190. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 4 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
