

# Weekly Analysis

## January 12, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 10,156 last week, an increase of 1.8 percent from the prior week's figure of 9,979 and a 1.6 percent increase from the January 2018 weekly average of 9,992. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 352. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 73,286 last week, an increase of 2.3 percent from the prior week's figure of 71,657 and a 7.5 percent decrease from the January 2018 weekly average of 79,213. Continued claims under Title 5 totaled 552. EUC continued claims totaled zero while EB continued claims totaled zero.
